01/014 Apologies, Declarations of Interest and Requests for Dispensation

Apologies were noted from Councillor Adrian Bridges.

There were no declarations of interest.

It was noted that on $6^{\text {th }}$ December 2012, a dispensation had been granted each member of Belmont Rural Parish Council to remove the restrictions under section 31 of the Localism Act 2011 in connection with discussions on setting the budget and precept request for this Parish on the grounds that without this dispensation, the number of members or co-opted members prohibited from participating in this business would be so great a proportion of the body transacting the business as to impede the transaction of this business. This dispensation to continue for each individual member until that member resigns as a Member of Belmont Rural Parish Council or until the next election of the whole parish council, whichever comes first. The Clerk confirmed that this dispensation was still valid for this meeting.

02/014 Public Participation

There were no members of the public in attendance at this meeting and therefore no matters raised under this agenda item.

## To consider the Annual Budget for the Parish Council for the year commencing 1.04.2014

The Clerk presented the draft budget for 2014-2015, noting that the operating/revenue budget had been approved by members on $31^{\text {st }}$ October, leaving other expenditure to be agreed at this meeting. Members noted that under each budget heading, suggested projects or beneficiary groups could only be considered as examples of potential expenditure as each project/group would need to be considered as a separate item at the time it is brought for formal consideration by the parish council.

Members considered potential expenditure under budget headings Capital and other Expenditure, Newsletter and Annual Report, Grants and Donations and Neighbourhood Development Plan. After some discussion, it was unanimously agreed that the following sums be allocated to those budget headings:

| Capital and other projects: | $£ 35,000$ |

| Grants and Donations: | $£ 17,000$ |
| Neighbourhood Development Plan: | $£ 12,000$ |

As a result, total budget for 2014-2015 was agreed as $£ 88,500.00$.

## 04/014 To issue the request for the Annual Precept for the year 2014-2015

Members noted that as several projects envisaged for the current financial year had been delayed partly as a result of the public works contract with Herefordshire Council moving from Amey to Balfour Beatty Living Places and in some cases as expected projects had not materialised as quickly as anticipated. As a result it is expected that reserves and the projected surplus would amount to a sum in the region of $£ 54,000$ at the end of the financial year. It was also noted that grant funding might be available towards the cost of producing a Neighbourhood Development Plan. Accordingly, it was unanimously agreed that a precept of $£ 50,000$ be requested from Herefordshire Council with remaining expenditure planned for 2014-2015 to be funded from reserves and/or grant funding as appropriate.

The Clerk was authorised to issue the formal claim accordingly.

There being no further business, the Chairman declared the meeting closed.
